Public Act 24 of 1995 created the MEGA tax credit to promote economic growth and job creation within the State. The tax credit is refundable toward a business's Michigan Business Tax (MBT) liability. It is awarded to Michigan businesses that entered into an agreement with the MEGA Board and committed to making capital investments and creating and/or retaining an agreed-upon number of jobs within the State. Because the MBT was replaced with the Corporate Income Tax effective January 1, 2012, no new MEGA tax credit agreements were made after December 2011. Between October 1, 2013 and June 30, 2016, MSF authorized for redemption \$1.4 billion in MEGA tax credits. The estimated remaining liability outstanding during October 2016 was \$7.3 billion.

AUDIT OBJECTIVES, CONCLUSIONS, FINDINGS, AND OBSERVATIONS

PROCEDURES TO APPROVE REQUESTS FOR TAX CREDIT CERTIFICATES

BACKGROUND

Businesses submit a request for a tax credit certificate to the Michigan Strategic Fund (MSF) after the business has met the Michigan Economic Growth Authority (MEGA) tax credit agreement requirements related to capital investments and the number of jobs created and/or retained. The minimum number of jobs to be created and/or retained is dependent on the business's type and location and whether it is expanding or locating in the State. MSF staff review and verify the information submitted with each request prior to issuing a tax credit certificate. This includes a comparison with the conditions set forth in the applicable MEGA tax credit agreement and a verification of the reported salaries and job information for a sample of employees.

A business attaches its MSF-issued tax credit certificate to its Michigan Business Tax (MBT) return to claim the credit. At the end of each quarter, MSF sends a report to the Michigan Department of Treasury to identify each business that has received a MEGA tax credit certificate, including the amount.

Public Acts 38 and 39 of 2011 replaced the MBT with the Corporate Income Tax effective January 1, 2012, and no new MEGA tax credit agreements were made after 2011. However, the MEGA tax credits that were awarded through December 31, 2011, under the MBT, will be preserved through the life of the agreements, the last of which will be available for redemption in 2030.

AUDIT OBJECTIVE

To assess the sufficiency of MSF's procedures to approve requests for MEGA tax credit certificates.

CONCLUSION

Sufficient.

FACTORS IMPACTING CONCLUSION

- We noted no significant errors for 31 judgmentally selected tax credit certificates totaling \$413.6 million that MSF approved between October 1, 2013 and June 30, 2016.
- MSF consistently validated salary information for a sample of employees contained in each tax credit request to the employees' W-2 forms* prior to issuing tax credit certificates.
- Employee wage data that sampled companies reported for 179 selected employees reconciled with the employees' wage data maintained by the State of Michigan with no material differences.

- MSF provided the Michigan Department of Treasury with the names of the businesses and the amounts of the MEGA tax credit certificates that MSF approved each quarter.
- MSF implemented procedures to correct the deficiencies reported in our April 2010 performance audit* of the Michigan Economic Growth Authority Tax Credit Program, Michigan Strategic Fund (271-0415-09), that were related to this objective.

COMPLIANCE WITH ANNUAL REPORTING REQUIREMENTS

BACKGROUND

Section 207.810 of the *Michigan Compiled Laws* (Public Act 24 of 1995, as amended) requires MSF to report its activities to the Legislature yearly on October 1. The *Michigan Compiled Laws* require the report to include the following minimum information:

- 1. The total amount of capital investment attracted under the Act.
- 2. The total number of qualified new jobs created under the Act.
- 3. The total number of new written agreements.
- 4. Names and locations of all authorized businesses and the names and addresses of all of the directors and officers of the corporation, the partners of the partnership or limited liability partnership, or the members of the limited liability company.
- 5. The amount and duration of the tax credit separately for each authorized business.
- 6. The number of jobs required to be created or retained under the MEGA agreement for each authorized business, including the maximum number of jobs which can be utilized to calculate the credit.
- 7. The amount of any fee, donation, or other payment of any kind from the authorized business to the Michigan Economic Development Corporation (MEDC) or a foundation or fund associated with MEDC paid or made in the previous reporting year or, if it is the first reporting year of the authorized business, for the immediately preceding three calendar years.
- 8. The total number of written agreements and the total capital investment required or otherwise anticipated for the credit under written agreements entered into under Section 207.808(5) of the *Michigan Compiled Laws* (retention agreements for a distressed business) and, of those written agreements, the number in which the MSF Board determined that it was in the public interest to waive one or more of the requirements of Section 207.808(1) of the *Michigan Compiled Laws*.
- 9. The actual number of jobs created or retained for the most recent period that information is available and all previous years under the written agreement, the total capital investment at that facility for tax credits authorized for that year and all previous years under the written agreement, and the total value of the tax

credits received under the written agreement for that year and all previous years under the written agreement.

10. A copy of each certificate issued under Sections 208.1431, 208.1431a, 208.1431b, and 208.1431c of the *Michigan Compiled Laws* (Michigan Business Tax Act).

AUDIT OBJECTIVE

To assess MSF's compliance with the *Michigan Compiled Laws* reporting requirements for its annual report to the Legislature.

CONCLUSION

Complied, with exceptions.

FACTORS IMPACTING CONCLUSION

- MSF complied with all applicable reporting requirements with one exception, as noted in Finding #1.
- MSF accurately reported to the Legislature the tax certificate amount it authorized for 100% of 38 judgmentally selected certificates issued between October 1, 2014 and September 30, 2015.
- MSF submitted its annual reports to the Legislature in a timely manner.
- Reportable condition* related to MSF not reporting the cumulative value of all previous years' MEGA tax credits received for each agreement in the fiscal year 2014 and 2015 annual reports.

FINDING #1

Consistency needed in the presentation of annual MEGA tax credit reports to designated recipients.

MSF needs to improve its reporting of annual MEGA tax credit information to designated members of the Legislature and the fiscal agency directors.

Section 207.810(1)(i) of the *Michigan Compiled Laws* requires that MSF annual reports include the cumulative value of the MEGA tax credit certificates issued for the current year and all previous years for each written agreement with each authorized business.

Our review of the fiscal year 2014 and 2015 annual MEGA tax credit reports disclosed that MSF did not include the tax credits issued in all previous years. Instead, MSF reported only the current reporting year certificate amounts awarded for each written agreement. MSF informed us that its omission was an oversight during the preparation of the fiscal year 2014 and 2015 reports and that it had previously included this information in its 2010 through 2013 annual reports. Inclusion of the yearly detail and total cumulative value of MEGA tax credits provides designated recipients with useful information to help evaluate the total historic value of the MEGA tax credits and the amount of tax credits that have been granted to each business each year.

RECOMMENDATION

We recommend that MSF improve its reporting of annual MEGA tax credit information to designated members of the Legislature and the fiscal agency directors.

AGENCY PRELIMINARY RESPONSE MSF provided us with the following response:

The MSF agrees with the recommendation and has corrected the issue for the fiscal year 2016 annual MEGA Tax Credit report. The MSF has implemented a new process to ensure continued compliance with its reporting obligations going forward.

OBSERVATION #1

Clarification needed for statutes that limit public transparency of MEGA tax credit information.

State laws restrict MSF and the OAG from reporting essential MEGA tax credit information to Michigan citizens and report users.

Statutory clarification is needed for certain statutes that limit the public transparency of MEGA tax credit information. Our audit identified instances in which confidentiality provisions in various State laws restricted MSF and the Office of the Auditor General (OAG) from reporting essential MEGA tax credit information to Michigan citizens and report users. We noted:

- a. The MEGA Act (specifically Section 207.810(1) of the *Michigan Compiled Laws*) requires MSF to annually report to the Legislature and the directors of the Senate and House Fiscal Agencies the total value of MEGA tax credits received for the year and all previous years for each MEGA agreement with each authorized business. However, the Revenue Act (specifically Section 205.28(1)(f) of the *Michigan Compiled Laws*) prohibits further disclosure of this tax credit information to others outside of the Legislature.
- b. Subsequent to December 31, 2011 and the elimination of any new MEGA tax credit agreements, MSF and MEDC renegotiated previously executed MEGA tax credit agreements with Ford, Fiat Chrysler, and General Motors. The amended agreements consolidated most of the businesses' previously executed agreements and capped the total amount of the tax credits that the businesses could receive throughout the term of the amended agreements.

However, when MSF and MEDC renegotiated with General Motors, the business requested that the estimated total value of the MEGA tax credit and tax credit cap amount remain confidential. MSF granted the request in December 2015 based on legal consultation in relation to its interpretation of a confidentiality provision in the MSF Act (specifically Section 125.2005(9) of the Michigan Compiled Laws). This Section allows that financial or proprietary information submitted by an applicant that is considered by the applicant and acknowledged by the MSF Board or designee of the Board to be confidential shall not be subject to disclosure requirements of the Freedom of Information Act (specifically Sections 15.243(1)(e) and (f) of the Michigan Compiled Laws). The MSF Act (specifically Section 125.2005(12) of the Michigan Compiled Laws) defines financial or proprietary information as information that if released might cause the applicant significant competitive harm.

Confidentiality provisions in law pertaining to information gathered from an agency under audit by the OAG are binding on us and prohibit further disclosure of such information. Therefore, in this case, the confidentiality agreement with one participant limited our ability to fully report information about MEGA tax credits for all participants because the reporting of estimated credits for the remaining participants would allow the readers of this report to determine the agreed-upon confidential amount.

Matters that could be addressed through statutory clarification of these various confidentiality provisions are:

- What type of tax information should be precluded from public disclosure? Should such preclusion exist for only the amount of taxes paid and/or taxable income, and not preclude estimated tax credits negotiated with public funds?
- When do State officials have the discretion to negotiate confidentiality provisions into individual agreements involving public funds? Do such agreements limit transparency and consistency among program participants or other taxpayers?
- Should the MSF Act more clearly define the type of information that could cause the applicant significant competitive harm? Does information such as the agreedupon amount of estimated and capped tax credits impact a business's competitive advantage?



The agreements identified in fiscal year 2012 were approved by the MEGA Board between October and December 2011.





MEGA Agreement Information

This exhibit identifies the individual businesses associated with the 732 MEGA agreements approved by the MEGA Board from April 20, 1995 through December 31, 2011. For some businesses, the information reported may not reflect the original agreement because the MEGA or MSF Board subsequently approved amendments. Some amendments occurred subsequent to December 31, 2011, after legislation eliminated the MEGA Board and the execution of future original agreements. The total estimated tax credit for all 732 agreements or subsequent amendments is \$14,183,479,938.

We cannot report the estimated tax credit for each individual business because it would allow the reader to determine the estimated and capped tax credit for General Motors that was amended in March 2016. MSF agreed to keep the estimated total value of General Motor's amended MEGA tax credit and tax credit cap amount confidential in accordance with Sections 125.2005(9) and 15.243(1)(f) of the *Michigan Compiled Laws*. According to Attorney General Opinion No. 6749, confidentiality provisions in law pertaining to information gathered from an agency under audit by the OAG are binding on us and prohibit further disclosure of such information. Therefore, we categorized the businesses within specified dollar ranges of estimated tax credit amount at the time of the original agreement or subsequent amendment. MEDC publicly reported in its annual report dated February 17, 2015 (prior to the March 2016 amendment and execution of the confidentiality agreement) that General Motor's estimated tax credit was \$2,114,093,875.

Column Descriptions

<u>Business Name</u> - The current name of the business that executed a MEGA tax credit agreement with the MEGA Board or MSF Board.

<u>MEGA Project Type</u> - The type of MEGA agreement approved (see glossary of abbreviations and terms for further detail).

MEGA Approval Date - Date originally approved by the MEGA Board.

<u>Project's County Location</u> - Location where the agreed-upon jobs were to be created/retained.

Projected Direct Jobs to Be Created - Estimated jobs to be created.

Projected Jobs to Be Retained - Estimated jobs to be retained.

Projected Capital Investment - The amount of funds to be invested in the business in Michigan.

Employment Credit Years Approved - The number of years that the business may apply for the tax credit certificate.

Amount of Estimated Credit per MEGA Agreement - The total amount of tax credit projected by MSF at the time the original agreement was executed and adjusted for any subsequent amendments. The projection was calculated by MSF using various economic and growth factors at the time the agreement and amendment were executed. This amount is not the actual amount of the tax credit certificate(s) already issued to the business or future tax credits to be issued. The actual amount of tax credit issued could be higher or lower depending on the number of jobs created or retained, the wages of such jobs, and the amount of capital investment completed. This is not intended to represent the remaining estimated liability. See Exhibit #6 for that information.

<u>Status</u> - Identifies whether the business can still claim a MEGA tax credit. "Ended" indicates that the business received tax certificates for all eligible years. "Dismissed" indicates that the application was approved by the MEGA Board, but the business did not receive tax certificates for all tax years or did not receive any tax credit. "Monitoring" indicates that the business may request certificates for future tax years.

<u>Number of Tax Credit Years Remaining</u> - This is the difference between the Employment Credit Years Approved and the number of tax credit certificates approved through June 30, 2016.

DESCRIPTION

Public Act 24 of 1995 created the MEGA tax credit to promote economic growth and job creation within the State and to create and prescribe the powers and duties of the MEGA Board. Public Act 24 also established qualifications for determining eligibility for tax credits and other incentives for authorized businesses and for qualified taxpayers.

The MEGA tax credit is a refundable tax credit* to a business's MBT liability. The MEGA tax credit is awarded to Michigan businesses that entered into an agreement with the MEGA Board and committed to making capital investments and creating and/or retaining an agreed-upon number of jobs within the State. The minimum number of jobs that have to be created and/or retained is dependent on the type and location of the business and if the business is expanding or locating in the State. There are tax credits granted for high-technology businesses (high-tech); businesses located in rural areas; distressed businesses; and other businesses locating, expanding existing operations, or committing to retaining jobs in the State.

There are five types of MEGA agreements:

- High-tech MEGA agreements* are for companies whose primary business activity is high-technology activity or a qualified high-wage activity. High-technology activity is defined as advanced computing, advanced materials (materials with engineered properties created through the development of specialized process and synthesis technology), biotechnology, electronic device technology, engineering or laboratory testing related to development of a product, technology that assists in the assessment or prevention of threats or damage to human health or the environment, medical device technology, product research and development, advanced vehicles technology, tool and die manufacturing, competitive edge technology, digital media, music production, and film and video. High-wage activity is defined as a business that has an average wage of 300% or more of the federal minimum wage. Sections 207.803(m), 207.803(p), and 207.803(q) of the Michigan Compiled Laws fully define high-technology activity, qualified high-technology business, and qualified high-wage activity, respectively.
- Rural MEGA agreements* are for eligible businesses located in a county with a population of 90,000 or less as defined by Section 207.803(u) of the Michigan Compiled Laws.

- businesses located within the State who agree to certain conditions regarding capital investment and the minimum number of jobs to be retained. Section 207.808(5) of the *Michigan Compiled Laws* identifies an eligible business for a retained MEGA agreement. These agreements were allowed under the original MEGA law but with requirements limiting the number of companies able to qualify for an agreement. The law was amended in 2000 to increase the number of companies that could qualify for a MEGA retention agreement.
- Standard MEGA agreements* are for eligible businesses that propose to create qualified new jobs in the State in manufacturing, mining, research and development, wholesale and trade, film and digital media production, office operations, tourism attraction facility, or qualified lodging facility. An eligible business does not include retail establishments or professional sports stadiums as defined by Section 207.803(g) of the Michigan Compiled Laws.
- Combination MEGA agreements* are for businesses with MEGA agreements that contain a provision for both a retention MEGA tax credit and a standard, rural, or high-tech MEGA tax credit.

Public Acts 38 and 39 of 2011 replaced the MBT with the Corporate Income Tax and eliminated the awarding of any new MEGA tax credits after December 2011. However, the credits that had already been awarded, but not yet certified, are preserved for the duration of the agreements.

Executive Order No. 2012-9 abolished the MEGA Board and transferred all the authority, powers, duties, functions, responsibilities, records, personnel, property, unexpended balances of appropriations, allocations or other funds to the MSF Board of Directors. Organizationally, the MEGA Tax Credit Program resides in MSF; however, MEDC staff provide support services to the MSF Board. Executive Order No. 2014-12 created the Department of Talent and Economic Development and transferred MSF from the Michigan Department of Treasury to the Department of Talent and Economic Development.

MEGA tax credits totaled \$1.4 billion for the period October 1, 2013 through June 30, 2016. Since inception, MEGA tax credits totaled \$2.3 billion through June 30, 2016.

MSF had five employees administering the MEGA Tax Credit Program during our audit period.

AUDIT SCOPE, METHODOLOGY, AND OTHER INFORMATION

AUDIT SCOPE

To examine the program and other records of the MEGA Tax Credit Program. We conducted this performance audit in accordance with generally accepted government auditing standards. Those standards require that we plan and perform the audit to obtain sufficient, appropriate evidence to provide a reasonable basis for our finding and conclusions based on our audit objectives. We believe that the evidence obtained provides a reasonable basis for our finding and conclusions based on our audit objectives.

PERIOD

Our audit procedures, which included a preliminary survey, audit fieldwork, report preparation, analysis of agency response, and quality assurance, generally covered October 1, 2013 through June 30, 2016.

METHODOLOGY

We conducted a preliminary survey to gain an understanding of MSF's MEGA Tax Credit Program and to establish our audit objectives, scope, and methodology. During our preliminary survey, we:

- Interviewed program personnel regarding their functions and responsibilities.
- Reviewed applicable State laws, executive orders, and MEGA Tax Credit Program review procedures.
- Obtained an understanding of the processes that MSF used when validating a business's tax credit certificate requests.
- Reviewed 7 judgmentally selected files for businesses that received tax credit certificates and recalculated the tax credit that MSF authorized.
- Reviewed and obtained an understanding of MSF's process to estimate the remaining outstanding MEGA tax credits.
- Reviewed 5 prior audit findings from our April 2010 performance audit of the Michigan Economic Growth Authority Tax Credit Program, Michigan Strategic Fund (271-0415-09), and verified MSF's corrective actions.

OBJECTIVE #1

To assess the sufficiency of MSF's procedures to approve requests for MEGA tax credit certificates.

To accomplish this objective, we:

- Judgmentally selected 31 of the 501 approved tax credit certificates for October 1, 2013 through June 30, 2016 and compared the submitted tax credit request information to the applicable MEGA agreement, amendments, and W-2 forms. Because of our judgmental selection, we could not project our results to the population.
- Validated the wage data submitted by the sampled businesses for 179 judgmentally selected employees to another data source maintained by the State of Michigan. Because of our judgmental selection, we could not project our results to the population.
- Reconciled the listing of businesses and tax credit certificate amounts provided to the Michigan Department of Treasury for the quarter from April 1, 2016 through June 30, 2016 with MSF's approved tax credit certificate records.
- Validated MSF's tax credit request review process by recalculating the tax credit amount for 31 judgmentally selected approved tax credit certificates that MSF issued between October 1, 2013 and June 30, 2016. Because of our judgmental selection, we could not project our results to the population.
- Validated selected fields in Salesforce* to MEGA tax agreements and certificates during our review of 31 MEGA tax credit certificate application files.

OBJECTIVE #2

To assess MSF's compliance with the *Michigan Compiled Laws* reporting requirements for its annual report to the Legislature.

To accomplish this objective, we:

- Compared the information that MSF included in its MEGA annual reports to the Legislature to the reporting requirements within the Michigan Compiled Laws.
- Verified business name, application number, tax year, and tax credit certificate amount included in the MEGA annual report for 17 judgmentally selected tax credit certificates issued between October 1, 2014 and September 30, 2015 to MSF's MEGA project files for compliance, completeness, and accuracy.
- Traced the approved tax credit certificate amount for 38 judgmentally selected hard-copy tax credit certificates from

the 192 that MSF issued between October 1, 2014 and September 30, 2015 to the amount that MSF included in its fiscal year 2015 MEGA annual report for the certificates.

 Tested the timeliness of the submission of the fiscal year 2014 and 2015 MEGA annual reports to the Legislature.

CONCLUSIONS

We base our conclusions on our audit efforts and any resulting material conditions* or reportable conditions.

When selecting activities or programs for audit, we direct our efforts based on risk and opportunities to improve State government operations. Consequently, we prepare our performance audit reports on an exception basis.

AGENCY RESPONSES

Our audit report contains 1 finding and 1 corresponding recommendation. MSF's preliminary response indicates that it agrees with the recommendation.

The agency preliminary response that follows the recommendation in our report was taken from the agency's written comments and oral discussion at the end of our audit fieldwork. Section 18.1462 of the *Michigan Compiled Laws* and the State of Michigan Financial Management Guide (Part VII, Chapter 4, Section 100) require an audited agency to develop a plan to comply with the recommendations and submit it within 60 days after release of the audit report to the Office of Internal Audit Services, State Budget Office. Within 30 days of receipt, the Office of Internal Audit Services is required to review the plan and either accept the plan as final or contact the agency to take additional steps to finalize the plan.

combination MEGA agreements

Agreements for businesses with MEGA agreements that contain a provision for both a retention MEGA tax credit and a standard, rural, or high-tech MEGA tax credit.

high-tech MEGA agreements

Agreements for companies whose primary business activity is high-technology activity or a qualified high-wage activity. Hightechnology activity is defined as advanced computing, advanced materials (materials with engineered properties created through the development of specialized process and synthesis technology), biotechnology, electronic device technology, engineering or laboratory testing related to development of a product, technology that assists in the assessment or prevention of threats or damage to human health or the environment, medical device technology product research and development, advanced vehicles technology, tool and die manufacturing, competitive edge technology, digital media, music production, and film and video. High-wage activity is defined as a business that has an average wage of 300% or more of the federal minimum wage. Sections 207.803(m), 207.803(p), and 207.803(q) of the Michigan Compiled Laws fully define hightechnology activity, qualified high-technology business, and qualified high-wage activity, respectively.

material condition

A matter that, in the auditor's judgment, is more severe than a reportable condition and could impair the ability of management to operate a program in an effective and efficient manner and/or could adversely affect the judgment of an interested person concerning the effectiveness and efficiency of the program.

Performance audits provide objective analysis to assist management and those charged with governance and oversight in using the information to improve program performance and operations, reduce costs, facilitate decision-making by parties with responsibility to oversee or initiate corrective action, and contribute to public accountability.

refundable tax credit

A tax credit that is received regardless of the amount of the taxpayer's tax liability.

reportable condition

A matter that, in the auditor's judgment, is less severe than a material condition and falls within any of the following categories: an opportunity for improvement within the context of the audit objectives; a deficiency in internal control that is significant within the context of the audit objectives; all instances of fraud; illegal acts unless they are inconsequential within the context of the audit objectives; significant violations of provisions of contracts or grant agreements; and significant abuse that has occurred or is likely to have occurred.

retention MEGA agreements

Agreements for existing businesses located within the State who agree to certain conditions regarding capital investment and the minimum number of jobs to be retained. Section 207.808(5) of the *Michigan Compiled Laws* identifies an eligible business for a retained MEGA agreement. These agreements were allowed under the original MEGA law but with requirements limiting the number of companies able to qualify for an agreement. The law was amended in 2000 to increase the number of companies that could qualify for a MEGA retention agreement.

rewritten

The current circumstances and problems noted require that the recommendation be rewritten rather than remain essentially the same.

rural MEGA agreements

Agreements for eligible businesses located in a county with a population of 90,000 or less as defined by Section 207.803(u) of the *Michigan Compiled Laws*.

Salesforce

Customer relationship management system used by MSF to document and monitor the MEGA Tax Credit Program.

standard MEGA agreements

Agreements for eligible businesses that propose to create qualified new jobs in the State in manufacturing, mining, research and development, wholesale and trade, film and digital media production, office operations, tourism attraction facility, or qualified lodging facility. An eligible business does not include retail establishments or professional sports stadiums as defined by Section 207.803(g) of the *Michigan Compiled Laws*.

W-2 form

A form that an employer must send to an employee and the Internal Revenue Service that reports an employee's wages and the amount of taxes withheld from the employee's wages.
